Terms of Service

IMPORTANT, READ CAREFULLY: YOUR USE OF AND ACCESS TO THE WEBSITE AND PRODUCTS AND SERVICES AND ASSOCIATED SOFTWARE (COLLECTIVELY, THE "SERVICES" OF CONTEMPORARY TECHNOLOGY UNIVERSITY. ("CONTECH" IS CONDITIONED UPON YOUR COMPLIANCE AND ACCEPTANCE OF THESE TERMS.

A. ELIGIBILITY

This Service is intended solely for Users who are thirteen (13) years of age or older, and any registration, use or access to the Service by anyone under thirteen (13) years of age is strictly prohibited and in violation of this Agreement. If you are under eighteen

(18) years of age but at least thirteen (13) years of age you may use the Service only if you either are an emancipated minor or possess legal parental or guardian consent, and are fully able and competent to enter into the terms, conditions, obligations, affirmations, representations, and warranties set forth in this Agreement, and to abide by and comply with this Agreement. If you are a parent or guardian subscribing to the Service for the benefit of your child, please be aware that you are fully responsible for his or her use and conduct on the Service, including financial charges and legal liability that he or she may incur. The Service is not available to any Users previously removed from the Service by CONTECH.
